Ushiku Redesign Project Artist In Residence is the art project utilizing the local shopping street and vacant shops in the Ushiku area, located in the south of Ichihara City, Chiba prefecture. The artists temporarily stay at Ushiku and create artwork exploring the local culture and communicating with local residents. We are calling for site-specific art projects utilizing local resources.

[Screening criteria]

- 1) Works highlighting abundant resources such as Ichihara City's history and nature and the attractiveness of the shopping street.
- 2) Works produced by temporarily staying at the site and collaborating with local residents.
- 3) Works with universal appeal.

Dates: Production Period: From December 2022 to February 2023/ Exhibition: March 2023 Application Period: October 10, 2022 (Mon) – November 13, 2022 (Sun) Site Inspection: October 29, 2022 (Sat) 11:00am-Booking is required. Details on the reverse side.

< Applicant Qualification >

Depending on the proposal, the artist should temporarily stay at the Ushiku area for a fixed period and collaborate with local residents.

<Numbers to be selected > About 1 to 3 works will be selected (subject to change).

< Documents for Submission >

Documents for Submission: The application must be submitted in Japanese, English or Chinese.

- Project title/ concept/ description/ production process/ materials/ size/ production and installation schedule/ estimatedbudget(ones that will create revenue, the income and expenditure plan should be submitted.)/ visual materials such as drawings, model photographs, illustrations, etc. to help visualize the final project. The text on the concept and contents of the project, it should be written in around 400 characters in Japanese or on half of an A4 sheet in Englishand Chinese.
- ③Reference materials such as a curriculum vitae or example(s) of previous work. Although A4 size is most preferable, other sizesmay be submitted, which should be folded into A4 size if possible.
- (2) Submit in CD or DVD containing digital data of the above ①②③ documents (in PDF, JPEG, or MS Office [Word or PowerPoint]).(Address on reverse side)

<Requirement>

- Number of submissions: No more than 3 proposed plans per person/group
- Artwork conditions: No limitations on size, materials, weight, etc.
- Site and environment conditions: In principle, the site must be returned to its original condition. In case the site has functions, those functions must be maintained.

In case the work is installed at a shop in operation, the operation must not be distracted. Detailed conditions differ in each shop and need further discussion.

• As the assigned shop may be changed according to the type and conditions of the work, the plan should accommodate flexibility.


